VISTA Assignment Objectives and Member Activities

Goal of the Project: To help ensure over 50,000 elementary children, over 1,500 teens, and hundreds of teachers at Title 1 schools (low-income, under-resourced communities) have access to book choice and ownership, one-to-one literacy tutoring, multicultural literacy programming, professional literacy development, and workforce development preparation to increase grade level reading proficiency, solving illiteracy, and in turn, reducing the number of people experiencing poverty by improving literacy in the communities. VISTA members will build capacity by reviewing current systems, and then planning, building, and implementing revised or new systems in the areas of external communications, fundraising development, volunteer recruitment, tutor recruitment, grant writing, and logistics and scaling the literacy tutoring program. The VISTA members will create sustainable organizational infrastructures that will allow READ USA to expand programming services in current and new communities.
